10:05: Dr. Bruno Pedreira Director of Beef & Forage Center –

- Dr. Pedreira outlined his phases of becoming acclimated to our state programs:
  - Phase 1: Understanding, visiting, foster communication
  - Phase 2: Meetings (Field days, Master Beef)
- He wanted to remind us that the UT Beef website is the main resource for agents and clientele <a href="https://utbeef.tennessee.edu/">https://utbeef.tennessee.edu/</a>
- Dr. Pedreira discussed forage systems Here are some key takeaways:
  - Focus on soil as well as animal product.
  - Variability can occur form acre to acre. Topography will sometimes determine number of soil tests.
  - 5-20 acres = 15-20 soil cores
- Choose Spring or Fall for taking samples. Keep consistent timeframe from year to year.
- 6-inch depth on samples is ideal.
- Target pH: Alfalfa >6.5; Fescue 6.0-7.0
- Yield/Economic Response Low levels will see the greatest economic response for fertilizer applications.
- Clover & lespedeza can add significant amounts of nitrogen to pastures. Almost the same as 60lb N

- Recipient must be a child of a TAAA&S member or Life Member in good standing with three or more years of TAAA&S membership.
- Recipient can be of any major with preference given to agriculture, family and consumer science, and other sciences (in descending order).
- Recipient can attend any university with preference given to attendance in the University of Tennessee System, TSU and the Tennessee Board of Regents system.
- Preference given to year in college: Freshman, Sophomore, Junior, Senior (in descending order).
- Selection committee should use other information on the scholarship application if needed to select recipient. Examples: leadership activities, grade average, etc.
- •A recipient can receive the scholarship only one time.

#### **Office Hours**

This statewide program is a collaborative effort between horticulture agents and specialists across the state. It is a live question/answer session via zoom to address the timeliest garden issues. Questions and pictures can be submitted in advance by agents and gardeners via the Hort Question Portal. Pictures are shared when each question is reviewed and we spend time in these four general categories each week- fruit, vegetables, turf, ornamentals. # Residential & Consumer Horticulture and TN Extension Master Gardener - Summary of Impact Statement by Natalie Bumgarner

In the Home and Garden knowledge area personnel and volunteers delivered 3,122 group meetings reaching 144,533 contacts along with 5,798 onsite visits (10,724 contacts), and 39,367 occurrences of personal communication (520,923 contacts). There were also 17,607,990 contacts reached by digital outreach events and 24,104,083 contacts reached by mass outreach. These efforts give a snapshot of the cumulative impact of Tennessee Extension agents, state and area specialists and TEMG volunteers in the area of residential and consumer horticulture in 2023. Extension Master Gardener volunteers serve through education and outreach in county programs for many years after training. The average personally reported value of the survey participants in our EMG training was \$1,687, so \$986,603 in value was derived just from that initial yearly training program. Additionally, volunteer service in the community also has a reported value Independent Sector, 2022 data). In 2023, 2,862 Tennessee Extension Master Gardener volunteers reporting 200,319 hours of service in consumer horticulture education in Tennessee that is valued at \$5,632,970.28.

#### Nursery Production - Summary of Impact Statement by Amy Fulcher

Tennessee nursery crop sales are ranked 7th in the nation (USDA Census of Horticultural Specialties, 2014). The Green Industry is a major component of not just the nation's, but also Tennessee's economy where it directly contributed \$830,900,000 in economic activity in 2020, and the total impact was projected at \$1,546,100,000 (Jensen et al., 2020). Keeping the Tennessee Green Industry up-to-date on applied research, new insects and diseases of concern, nursery irrigation, container substrate alternatives, turf care, worker safety, consumer behavior and other pressing issues are a priority for the statewide Extension nursery crops specialist and other specialists. The Tennessee Green Industry Day is a joint educational program of the University of Tennessee and the Tennessee Nursery and Landscape Association. At the Tennessee Green Industry Day, we feature the latest research being conducted at UT through hands-on demonstrations, guided plant diagnostic walks at the UT Gardens, and indoor classroom-style sessions. Growers, landscapers, arborists, and retailers in attendance estimated saving or increasing their revenue by \$216,000 due to information presented at the program.

#### Commercial Turf Weed Management - Summary of Impact Statement by Jim Brosnan

Overall, the integrated weed management strategies program offers a substantial positive impact on the Tennessee economy. Previous research highlighted that every \$1.00 spent on turfgrass management in Tennessee yields a \$1.66 positive return. Given that the industry is valued at \$5.8 billion, even if only 1% of end-users are impacted by this program, the economic yield is over \$50 million. Programs include, TN Turf Tuesday, Mobile Weed Manual, Certified Lawn Care Professional program, and TN Weed Diagnostic Center.
